#### FAQ's

#### Q: What is a webinar?

A: A webinar is a live, instructor-led CE course. These are broadcast during specific times of the day. All Webinar start times are hosted in CST.

#### Q: What type of credit is given for AHEC webinars?

A: Currently, all AHEC webinars are approved through AHRA for Category A credit.

#### Q: Do I need my microphone or camera?

A. No, Webinars do not require the use of your camera or microphone. To direct any questions to the instructor, please use the chat box or Q&A box.

#### Q: How/when will I receive my certificate?

A: You will receive your certificate as a PDF attachment to the email address given at registration within 1 business day after the course ends.

#### Q: What is the refund/cancellation policy regarding the webinars?

A: There are NO refunds for webinars or simulcasts unless AHEC is responsible for cancelling the event. There are NO refunds given for no-shows.

### Advanced Health Education Center, Ltd. Cancellation & Refund Policy for Live Events and Webinars:

#### For Webinars:

- Advanced Health Education Center (AHEC) decides 1 day prior to the webinar date if an webinar will be cancelled. If AHEC cancels a webinar, the participant will be awarded one of the following: a full refund, a tuition credit to be used within the next year, or a transfer into another webinar course of equal or lesser value (before discounts). If the participant chooses to transfer to a webinar of higher value, the participant is responsible for the price difference.
- Attendees that cannot log in due to technical difficulties beyond their control may be eligible for a refund or tuition credit, but must contact AHEC on the day of the webinar before the conclusion of the course. No refund will be made if you do not contact AHEC before the close of the event.
- Participant cancellations received by 5pm CST the day prior to the course date will be allowed a tuition credit, however no refunds will be made for participant cancellations.

#### For Live Events:

- AHEC reserves the right to cancel a Live Event course if the minimum number of attendees is not met. Customers are eligible for a full refund if AHEC cancels a course.
- AHEC is not responsible for travel costs incurred by attendees, including non-refundable airline tickets.
- Refunds, minus a \$20 processing fee, will be granted for cancellations received prior to two weeks before the
  program. Cancellations received within two weeks of the program are not eligible for a refund and will receive
  tuition credit toward a future AHEC course or home study, minus the \$20 processing fee. No refunds will be
  made after the course starts/occurs.
